





LOWER FLOOR





GROUND FLOOR SUITES 25. 28, 42, & 67

















GROUND LEVEL (SECOND STOREY) TYPICAL CROSS SECTION


ENTRANCE AT GROUND FLOOR PORCH


MAIN FLOOR









MAIN FLOOR


