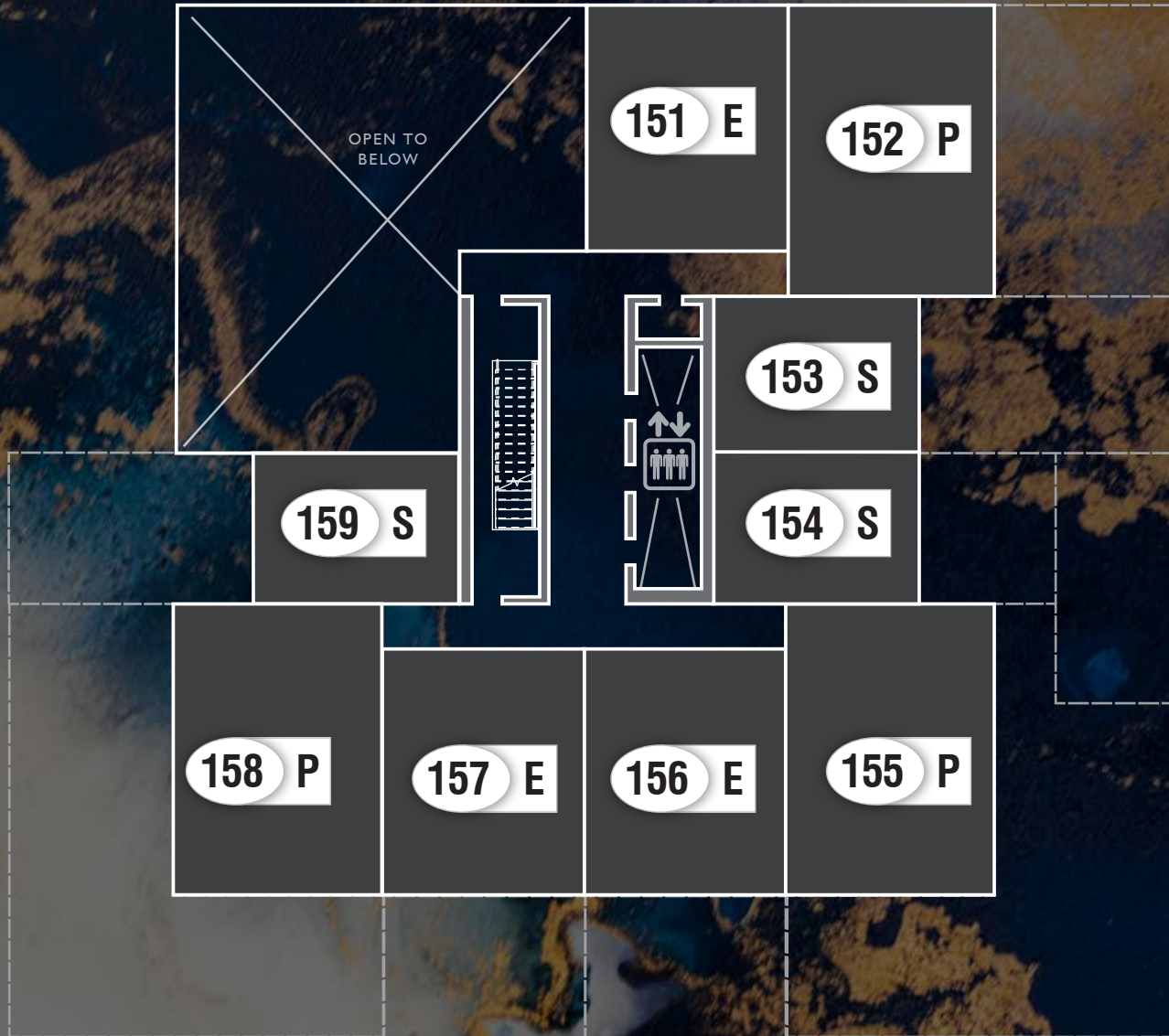
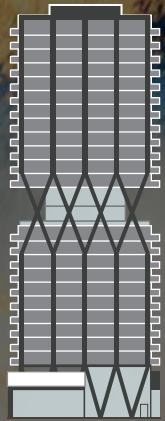

A FLOOR PLAN

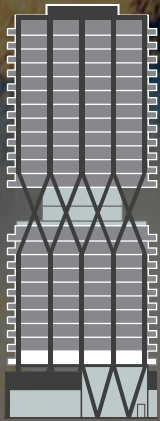

A FLOOR PLAN

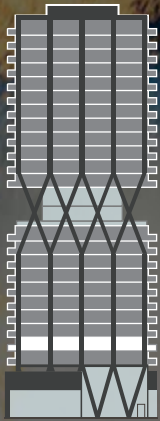

A FLOOR PLAN

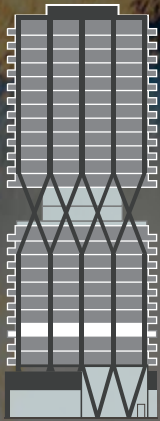

A FLOOR PLAN

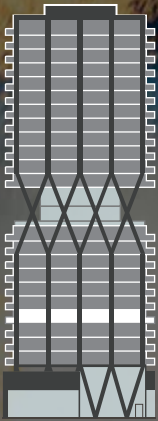

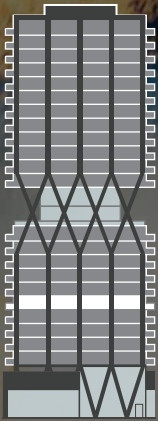

A FLOOR PLAN

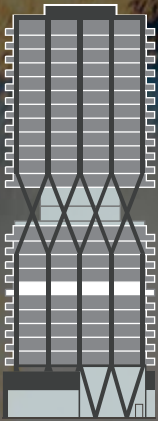

A FLOOR PLAN

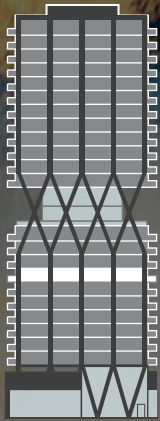

A FLOOR PLAN

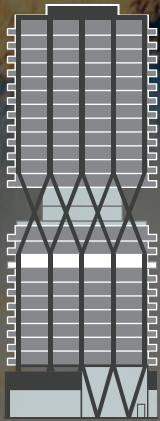

A FLOOR PLAN

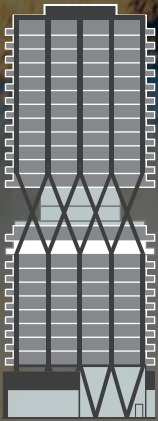

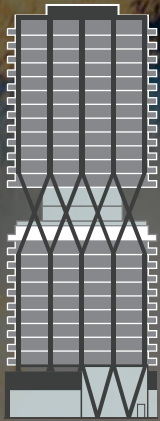

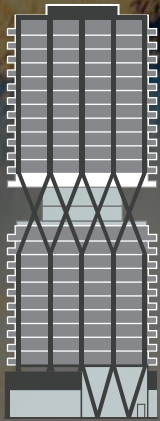

A FLOOR PLAN

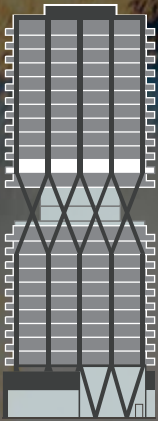

A FLOOR PLAN

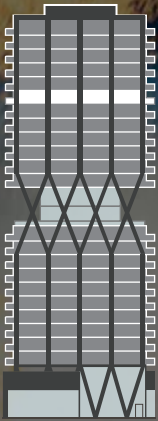

A FLOOR PLAN

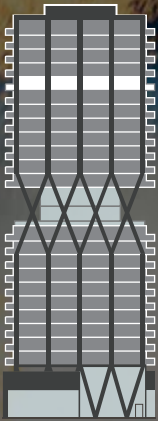

A FLOOR PLAN

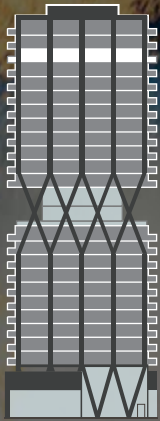

A FLOOR PLAN

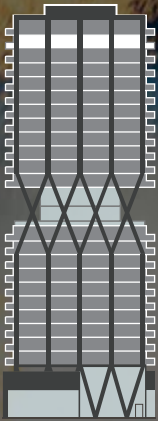

A FLOOR PLAN

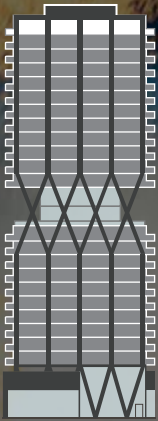
